## What is Child Tax Credit?

Child Tax Credit is a payment to support families with children.
You can claim Child Tax Credit if you are responsible for one child (or young person) or more. You do not have to be working to claim.

Child Tax Credit will provide support for:
a) a child until 1 September following his or her 16th birthday; or
b) a young person aged 16 to 18 who:

- is in full-time education, up to and including A-levels or NVQ level 3
- has left full-time education but does not have a job or a training place and has registered with the Connexions service
- is not claiming Income Support or Tax Credits in his or her own right
- is not serving a custodial sentence of four months or more imposed by a court.
